Title.

1. These Regulations may be cited as the Housing Association Regulations.

Form of register.

2. The manner prescribed under section 4(1) of the Act in Form of which the Registrar shall maintain the register of housing register. associations shall be as contained in Schedule 1.

Fee for inspecting register, etc.

3. (1) The fee prescribed under section 4(2) of the Act for inspection of the register of housing associations shall be £1.

(2) The fee prescribed under section 4(3) of the Act for a certificate, copy or extract shall be £1.

Form of memorandum.

4. The form of memorandum of a housing association prescribed under section 6(1) of the Act shall be as contained in Schedule 2.

Form of rules.

5. The form of rules of a housing association prescribed under section 8(2) of the Act shall be as contained in Schedule 3.

Fee for registration.

6. The fee prescribed under section 9(1) of the Act, to be payable for the registration of a housing association, shall be £25.

Form of registration certificate.

7. The form prescribed under section 9(2) of the Act for the certificate of registration of a housing association shall be as contained in Schedule 4.

Form and contents of annual return.

8. The form of annual return of a housing association prescribed under section 21(1) of the Act and the further information prescribed under section 21(2)(c) to be stated therein shall be as contained in Schedule 5.
