Title and commencement.

1. (1) These Rules may be cited as the Seashore (Prohibition of Camping) Rules, 1986.

(2) These Rules shall come into operation on the 26th day of April 1986.

Interpretation.

2. In these Rules—

“designated beach” means any seashore, that is to say, any beach including the foreshore thereto, specified in the Schedule.

Camping on designated beaches prohibited.

3. For the purpose of avoiding danger to the public health and of ensuring the welfare of those using or within the vicinity of, any designated beach, the erection or placing on any part of such beach of any booth, tent, screen, shed, stand, hut or stall (whether fixed or movable) and used or intended to be used either intermittently or regularly for human habitation, is prohibited.

Notice of prohibition.

4. Where any seashore has been designated in the Schedule a notice shall be erected in a conspicuous position on such seashore to the effect that camping is thereon prohibited.

Penalty.

5. Any person who contravenes the provisions of Rule 3 shall be guilty of an offence and liable on summary conviction to a fine not exceeding level 3 on the standard scale.

Saving.

6. Any act of any officer or employee of the Government necessary to the proper exercise of his duty in relation to any designated beach and the erection and placing of any tent or other structure thereon under and in accordance with the provisions of a permit issued under Rule 3 of the Seashore Rules, shall not be deemed to be an offence against these Rules.

SCHEDULE

Rule 2.

BEACHES ON WHICH CAMPING IS PROHIBITED.

1. All that stretch of seashore between the northern boundary of the Caleta Palace Hotel and the southern boundary of the Both Worlds Hotel, including the areas more generally known as Black Strap Cove (some times called Miami Beach) and Shirley Cove.
2. Catalan Bay Beach.
3. Eastern Beach.
