Title and commencement.

1(1). This notice may be cited as the Litter (Proper Container) Notice 1995.

(2) The specification of streets and places under this notice shall take effect 7 days from the day of publication.

Specification of streets and places.

2. The Litter Authority has specified the streets and places set out in column 1 of the Schedule as streets and places in which no refuse shall be placed for collection except in the proper container.

Specified sites for proper container.

3. The Litter Authority has specified the sites set out in column 2 of the Schedule as the site of the proper container for the receipt of refuse in respect of the street or public place specified in the corresponding entry in column 1 of the Schedule.
