1. This Order may be cited as the Census Act (2001 Census) Order 2001.

**Date of the Census.**

2. A Census for Gibraltar shall be taken on Monday the 12th day of November 2001.

**Persons in respect of whom the census shall be taken.**

3. The Census shall be in respect of all persons resident in Gibraltar on the night of Monday 12th November 2001, in respect of whom such numerical returns shall be rendered as may be required

**Persons by whom the Census shall be taken.**

4.(1) The Census shall be taken by a Commissioner to be appointed by virtue of section 3 of the Act.

(2) In the performance of his duties, the Commissioner shall be assisted by such number of persons as may be appointed to act as enumerators and Senior Census Officers.
