Title.

1. These Regulations may be cited as the Transport (Transfer of Operator Licences) Regulations 2004.

Transfer of operator licences.

2.(1) An operator licence granted to any person under the provisions of the principal Act may, subject to the prior approval of the Commission, be transferred to another person.

(2) An application to the Commission for approval to transfer an operator licence under sub-regulation (1) shall be in the form set out in the Schedule.

Duties of the Commission in considering applications.

3.(1) In exercising its discretion to approve or not approve the transfer of an operator licence, the Commission shall have regard, in relation to the proposed transferee, to the matters specified in section 28(1)(c) and (d) of the principal Act and the provisions of Schedule 1 relating thereto.

(2) Should the Commission approve the transfer of an operator licence pursuant to an application under regulation 2(2), it shall amend the said licence by deleting the name and address and other details of the holder of the said licence and substituting therefor the name, address and other details of the transferee.
