*In exercise of the powers conferred on me by regulation 8 of the Traffic (Parking and Waiting) Regulations 2011 I have established a Parking Scheme within the South District (Zone 2) as set out below—*

Parking facilities in the South District Zone are divided into three types—

- (a) Free motor cycle parking in which anyone can park free of charge;
- (b) Free car parking in which anyone can park free of charge;
- (c) Car parking spaces in which only people who live within this Zone and WHO HOLD A PERMIT may park. This parking is free of charge.

A “Residents’ Only Parking Permit”, which may be obtained from Gibraltar Car Parks Ltd, allows a holder to park in any general “Residents’ Permit Holders Only” parking area within the Zone as set out below:

**“South District Residents’ Parking Permit”**

Holders of this permit may park in any “South District Resident Permit Holders Only” parking area ONLY and NOT within “Alameda Estate Resident Permit Holders Only”, “Schomberg Resident Permit Holders Only”, “6/8 Scud Hill Resident Holders Only”, or “Electra, Belvedere & 24 Scud Hill Resident Permit Holders Only” parking areas.

**“South District Alameda Estate Residents’ Parking Permit”**

Holders of this permit may park in any “South District Resident Permit Holders Only” and “Alameda Estate Resident Permit Holders Only” parking areas ONLY and NOT within “Schomberg Resident Permit Holders Only”, “6/8 Scud Hill Resident Holders Only”, or “Electra, Belvedere & 24 Scud Hill Resident Permit Holders Only” parking areas.

**“South District Schomberg Residents’ Parking Permit”**

Holders of this permit may park in any “South District Resident Permit Holders Only” and “Schomberg Resident Permit Holders Only” parking areas ONLY and NOT within “Alameda Estate Resident Permit Holders Only”, “6/8 Scud Hill Resident Holders Only”, or “Electra, Belvedere & 24 Scud Hill Resident Permit Holders Only” parking areas.

**“South District 6/8 Scud Hill Residents’ Parking Permit”**

Holders of this permit may park in any “South District Resident Permit Holders Only” and “6/8 Scud Hill Resident Permit Holders Only” parking areas ONLY and NOT within “Alameda Estate Resident Permit Holders Only”, “Schomberg Resident Holders Only”, or “Electra, Belvedere & 24 Scud Hill Resident Permit Holders Only” parking areas.

**“South District Electra, Belvedere & 24 Scud Hill Residents’ Parking Permit”**

Holders of this permit may park in any “South District Resident Permit Holders Only” and “Electra, Belvedere & 24 Scud Hill Resident Permit Holders Only” parking areas ONLY and NOT within “Alameda Estate Resident Permit Holders Only”, “Schomberg Resident Holders Only”, or “6/8 Scud Hill Resident Permit Holders Only” parking areas.
