In exercise of the powers conferred on him by section 15 of the Limited Partnerships Act, and all other enabling powers, the Minister has made the following Rules—

Title and commencement.

1. These Rules may be cited as the Limited Partnerships (Fees and Forms) Rules 2013 and come into operation on 1 January 2014.

Fees payable to the Registrar.

2. The fees specified in the Schedule to these Rules shall be payable to the Registrar appointed under the Limited Partnerships Act in respect of the matters so specified.

Prescribed forms.

3. The forms prescribed for the purposes of section 15(4) shall be the forms approved from time to time by the Registrar for the purpose of ensuring the proper operation of the Act and the Registrar shall—

- (a) make such forms available in whatever medium they may be delivered to him; and
- (b) notify the fact of any change in such forms by notice in the Gazette no later than one month before the changed form shall operate.
