# 2022/298 Census Act (2022 Census) Regulations 2022

In exercise of the powers conferred on it by section 4 of the Census Act and of all other enabling powers, the Government has made the following Regulations-

### Title and application.

1951-09

1. These Regulations may be cited as the Census Act (2022 Census) Regulations 2022 and shall apply to the Census to be taken in 2022.

### Commencement.

2. These Regulations come into operation on the day of publication.

### **Enumeration Areas.**

3. Gibraltar shall be divided into districts for the purpose of the Census in accordance with the Enumeration Areas specified in Schedule 1 to these Regulations.

### Appointment of persons in connection with the Census.

4. The Commissioner appointed by virtue of section 3 of the Act shall-

- (a) appoint such number of persons to act as Enumerators and Senior Census Officers in the districts specified in Schedule 1;
- (b) appoint such number of data input Census Officers as in the Commissioner's opinion are necessary;
- (c) cause the name of any person appointed by virtue of subregulation (a) or (b) to be published in a Government Notice.

### Duties of Enumerators, Senior Census Officers and Census Officers.

5. A person appointed as an Enumerator, Senior Census Officer or as a Census Officer under regulation 4, shall carry out the duties prescribed by the Commissioner in the manner required by the Act and the instructions of the Commissioner.

### Statutory declaration.

6. Every person appointed by virtue of regulation 4 shall make a statutory declaration in the form specified in Schedule 2 with respect to the performance of their duties and shall make this declaration before a Justice of the Peace.

# Prisons and other institutions.

7. The Superintendent of the Prison and the person in charge of each of the establishments listed in Schedule 3 to these Regulations, shall make a return in accordance with the provisions of the Act as is required of them and shall conform with the instructions issued to them in respect of that return by the Commissioner.

### **Obligation to provide information.**

8. Any person present in Gibraltar on Monday 14<sup>th</sup> day of November 2022, shall provide to a person required by the Census Act (2022 Census) Order 2022 to complete and return the information necessary for that person to complete the required return.

- (c) being a person required by any order or regulations made under this Act to make, sign or deliver any document, makes, signs or delivers, or causes to be made, signed, or delivered a false document; or
- (d) being a person required in pursuance of any such order or regulations to answer any question, refuses to answer or gives a false answer to that question;

is guilty of an offence and is liable on summary conviction, to a fine of £50.

- (a) being a person employed in taking a census, without lawful authority publishes or communicates to any person otherwise than in the ordinary course of such employment, any information acquired by him in the course of his employment; or
- (b) having possession of any information which to his knowledge has been disclosed in contravention of this Act, publishes or communicates that information to any other person,

is guilty of an offence and is liable, on summary conviction, to imprisonment for six months and to a fine of £100.
