# UKRAINE (TRAVEL RESTRICTIONS) (AMENDMENT) (NO 17) REGULATIONS 2018

In exercise of the powers conferred on him by section 52A of the Immigration, Asylum and Refugee Act, and for the purposes of implementing Council Decision (CFSP) 2018/706 of 14 May 2018 amending Decision 2014/145/CFSP concerning restrictive measures in respect of actions undermining or threatening the territorial integrity, sovereignty and independence of Ukraine, the Minister has made the following Regulations-

#### Title.

1. These Regulations may be cited as the Ukraine (Travel Restrictions) (Amendment) (No17) Regulations 2018.

# Commencement.

2. These Regulations shall come into operation on the day of publication.
