## BILL

FOR

AN ACT to appropriate sums of money to the service of the period ended 31<sup>st</sup> day of March 2022.

ENACTED by the Legislature of Gibraltar.

### **Title and commencement.**

1. This Act may be cited as the Supplementary Appropriation (2021/2022) Act 2024 and comes into operation on the day of publication.

### **Consolidated Fund Supplementary Appropriation of Recurrent Expenditure 2021/2022.**

2.(1) The Accountant General may, under the authority of a general warrant issued in accordance with the provisions of the Public Finance (Control and Audit) Act, pay out of the Consolidated Fund of Gibraltar for the period ended 31st March 2022, a further sum not exceeding £30,800,000.

(2) The said sum shall be appropriated only to such purposes and shall not exceed such amounts as are set out in Part 1 of the Schedule to this Act.

### **Consolidated Fund Supplementary Appropriation of Contributions 2021/2022.**

3.(1) The Accountant General may, under the authority of a general warrant issued in accordance with the provisions of the Public Finance (Control and Audit) Act, pay out of the Consolidated Fund of Gibraltar for the period ended 31st March 2022, a further sum not exceeding £70,610,000.

(2) The said sum shall be appropriated only to such purposes and shall not exceed such amounts as are set out in Part 2 of the Schedule to this Act.

**Improvement and Development Fund Supplementary Appropriation of Expenditure 2021/2022.**

4.(1) The Accountant General may, under the authority of a general warrant issued in accordance with the provisions of the Public Finance (Control and Audit) Act, pay out of the Improvement and Development Fund of Gibraltar for the period ended 31st March 2022, a further sum not exceeding £354,000.

(2) The said sum shall be appropriated only to such purposes and shall not exceed such amounts as are set out in Part 3 of the Schedule to this Act.

**Supplementary Appropriation of Recurrent Expenditure of Public Undertakings 2021/2022.**

5.(1) The Accountant General may, under the authority of a general warrant issued in accordance with the provisions of the Public Finance (Control and Audit) Act, pay out of the Consolidated Fund of Gibraltar for the period ended 31st March 2022, a further sum not exceeding £48,574,000.

(2) The said sum shall be appropriated only to such purposes and shall not exceed such amounts as are set out in Part 4 of the Schedule to this Act.

**Supplementary Appropriation of Capital Expenditure of Public Undertakings 2021/2022.**

6.(1) The Accountant General may, under the authority of a general warrant issued in accordance with the provisions of the Public Finance (Control and Audit) Act, pay out of the Improvement and Development Fund of Gibraltar for the period ended 31st March 2022, a further sum not exceeding £653,000.

(2) The said sum shall be appropriated only to such purposes and shall not exceed such amounts as are set out in Part 5 of the Schedule to this Act.

## EXPLANATORY MEMORANDUM

The purpose of this Bill is to appropriate further sums of money necessary to meet Government expenditure for the period ended 31<sup>st</sup> day of March 2022.

### **Consolidated Fund Expenditure**

The sum of £101,410,000 is required to fund recurrent expenditure as follows:

- An appropriation of £30,800,000 is required to meet additional departmental Consolidated Fund expenditure.
- A further £3,000,000 is required by the Improvement and Development Fund to fund capital expenditure
- A further £67,610,000 is required to meet additional expenditure met from the COVID-19 Response Fund.

### **Improvement and Development Fund Expenditure**

The sum of £354,000 is required to fund additional capital expenditure incurred under the following:

- Head 101 Works and Equipment

Government Computerisation Programme	£354,000

### **Recurrent expenditure of Public Undertakings**

The sum of £48,574,000 is required to fund additional recurrent expenditure of the Public Undertakings. This expenditure is funded out of monies paid to the Public Undertakings from funds voted from the Consolidated Fund through the Appropriation Act 2022 and or Section 3 of this Act.

### **Capital expenditure of Public Undertakings**

The sum of £653,000 is required to fund additional capital expenditure of the Public Undertakings. This expenditure is funded out of monies paid to the Public Undertakings from funds voted from the Improvement and Development Fund through the Appropriation Act 2022 and or Section 4 of this Act.
