AN ORDINANCE to amend the Births and Deaths Registration Ordinance.

ENACTED by the Legislature of Gibraltar.

#### Short Title and commencement.

1. This Ordinance may be cited as the Births and Deaths Registration (Amendment) Ordinance 1986, and shall come into and operation on such date as the Governor may by notice in the Gazette appoint.

#### Amendment of Section 2.

- 2. Section 2 of the Births and Deaths Registration Ordinance (in this Ordinance referred to as the principal Ordinance) is amended -. .
  - (a) by inserting before the definition of `occupier' the following definitions:-

""birth" includes live-birth and still-birth;"

"`burial' includes interment, cremation, burial at sea;"

(b) by inserting immediately after the definition of `occupier' the following:-

"`minister' includes the representative of any religious organization or other person in charge of a burial service;".

## Amendment of Section 20.

3. Section 20 of the principal Ordinance is repealed and the following substituted therefor:-

## "Register of deaths.

20. The Registrar shall keep a register of deaths, in which he shall record the death of every person who dies in Gibraltar."

## Amendment of Section 35.

- 4. Section 35 of the principal Ordinance is amended-
  - (a) by re-numbering subsection (2) as subsection (3);
  - (b) by inserting after subsection (1) the following-
    - "(2) In the case of every burial in the cemetery in North Front the person in charge of the funeral shall before the commencement of the burial ceremony deliver to the cemetery keeper the certificate of the Registrar issued under section 33, or the order of the Coroner made under section 34; and the cemetery keeper shall, after the burial endorse upon such certificate or order the date of the burial, sign his name on such certificate or order, and forthwith send such certificate or order as endorsed and signed to the Registrar."

#### Amendment of Section 40.

- 5. Section 40 of the principal Ordinance is amended-
  - (a) by repealing the words "in any Government hospital or"; 6
  - (b) by inserting after the word "barracks" the words "or quarters so provided".

## New section 42.

6. The principal Ordinance is amended by adding the following section-

#### "Notices, etc.

# Sending of documents by post.

42. Any notice, information, certificate, requisition, return or other document required by or under this Ordinance may be sent by post."

# Increase of penalties.

7.The penalties prescribed by the principal Ordinance and set out in the first and second columns of the Schedule are repealed and replaced by the penalties set out in the third column of the Schedule.
