# **CENSUS ORDINANCE (2001 CENSUS) REGULATIONS 2001** Title and application.

1. These Regulations may be cited as the Census Act (2001 Census) Regulations 2001 and shall apply to the Census to be taken in 2001.

### **Enumeration Areas.**

2. Gibraltar shall be divided into districts for the purpose of the Census in accordance with the enumeration areas specified in Schedule 1 to these regulations.

### Appointment of persons in connection with the Census.

- 3. The Commissioner appointed by virtue of section 3 of the Act shall:
  - (a) appoint such number of persons to act as enumerators and Senior Census Officers in the districts specified in Schedule 1;
  - (b) appoint such number of data input operators as in his opinion are necessary;
  - (c) cause the name of any person appointed by virtue of paragraph(a) or (b) to be published in a Government Notice.

### Duties of enumerators, Senior Census Offices or data input operators.

4. A person appointed as an enumerator, Senior Census Officer or as a data input operator under regulation 3 shall carry out the duties prescribed by the Commissioner in the manner required by the Act and the instructions of the Commissioner.

#### Statutory declaration.

5. Every person appointed by virtue of regulation 3 shall make a statutory declaration in the form specified in Schedule 2 with respect to the performance of their duties and shall make such declaration before a Justice of the Peace.

#### Prisons and other institutions.

6. The Superintendent of the Prison and the person in charge of each of the establishments listed in Schedule 3 to these Regulations shall make such return in accordance with the provisions of the Act as is required of them and shall conform with the instructions issued to them by the Commissioner in respect of that return.

## CENSUS ORDINANCE (2001 CENSUS) REGULATIONS 2001

7. Any person present in Gibraltar on the night of Monday 12th day of November 2001 shall provide to a person required by the Census Act (2001 Census) Order 2001 to complete and return the information necessary for that person to complete the required return.

# Offence.

8. Failure to comply with the requirements of these regulations shall be an offence punishable on summary conviction by a fine at level 1 on the standard scale.

# CENSUS ACT

#### **Offences and penalties**

6.(1) A person who-

- (a) refuses or neglects to comply with or acts in contravention of any of the provisions of this Act or any order or regulations made under this Act;
- (b) being a person required under this Act to make a statutory declaration with respect to the performance of his duties, makes a false declaration;
- (c) being a person required by any order or regulations made under this Act to make, sign or deliver any document, makes, signs, or delivers, or causes to be made, signed, or delivered a false document; or
- (d) being a person required in pursuance of any such order or regulations to answer any question, refuses to answer or gives a false answer to that question;

is guilty of an offence and is liable on summary conviction to a fine not exceeding  $\pounds 50$ .

- (a) being a person employed in taking a census, without lawful authority publishes or communicates to any person otherwise than in the ordinary course of such employment, any information acquired by him in the course of his employment; or
- (b) having possession of any information which to his knowledge has been disclosed in contravention of this Act, publishes or communicates that information to any other person,

is guilty of an offence and is liable on summary conviction to imprisonment for six months and to a fine of £100.
