In exercise of the powers conferred on it by section 2 of the Census Act, and of all other enabling powers, the Government has made the following Order—

Title.

1. This Order may be cited as the Census Act (2012 Census) Order 2012.

Date of the Census.

2. A Census for Gibraltar shall be taken on Monday the 12th day of November 2012.

Persons in respect of whom the census shall be taken.

- 3.(1) The Census shall be in respect of all persons deemed to be usually resident in Gibraltar on Monday 12th November 2012, in respect of whom such numerical returns shall be rendered as may be required.
- (2) For the purposes of sub-paragraph (1) the expression "deemed to be usually resident" means anyone who, on the 12th November 2012 is in Gibraltar and has stayed or intends to stay in Gibraltar for a period of 12 months or more.

Persons by whom the Census shall be taken.

4.(1) The Census shall be taken by a Commissioner to be appointed by virtue of section 3 of the Act.
