Census Act (2022 Census) Order 2022

In exercise of the powers conferred on it by section 2 of the Census Act, and of all other enabling powers, the Government has made the following Order-

Title.

1. This Order may be cited as the Census Act (2022 Census) Order 2022.

Commencement.

2. This Order comes into operation on the day of publication.

Date of the Census.

3. A Census for Gibraltar shall be taken on Monday the 14th day of November 2022.

Persons in respect of whom the Census shall be taken.

- 4.(1) The Census shall be in respect of all persons deemed to be-
 - (a) usually resident;
 - (b) a short-term resident; or
 - (c) a visitor,

in Gibraltar on Monday 14th November 2022, and in respect of whom such numerical returns shall be rendered as may be required.

- (2) For the purposes of paragraph (1) the expressions-
 - (a) "deemed to be usually resident" means anyone who, on the 14th November 2022 is in Gibraltar and has stayed or intends to stay in Gibraltar for a period of 12 months or more;
 - (b) "deemed to be a short-term resident" means anyone born in a country or territory outside Gibraltar who, on the 14th November 2022 is in Gibraltar and has stayed or intends to stay in Gibraltar for a period of 3 months or more but less than 12 months:
 - (c) "deemed to be a visitor" means anyone who is resident in a country or territory outside Gibraltar and on the 14th November 2022 is in Gibraltar and has stayed or intends to stay in Gibraltar for a period of less than 3 months.

- (3) The persons referred to in paragraph (1)-
 - (a) are not required to provide the particulars listed in article 6 (f) items 19 and 20;
 - (b) must provide the particulars that are applicable to them as indicated under article 6.

Persons by whom the Census shall be taken.

- 5.(1) The Census shall be taken by a Commissioner to be appointed by virtue of section 3 of the Act.
- (2) In the performance of the Commissioner's duties, the Commissioner shall be assisted by such number of persons as may be appointed to act as Enumerators and Senior Census Officers.

Particulars to be stated in returns.

- 6. The following particulars shall be stated in the returns:
 - (a) For all persons (except visitors):
 - 1. Name.
 - 2. Relationship to the Householder.
 - 3. Date of birth.
 - 4. Sex
 - 5. Legal marital or registered civil partnership status.
 - 6. Sex of persons in legal marriage or registered civil partnership.
 - 7. Nationality.
 - 8. Country of birth.
 - (b) For persons not born in Gibraltar (except visitors):
 - 9. Month and year of most recent arrival to live in Gibraltar.
 - 10. Intended length of stay in Gibraltar.
 - (c) For all persons (except visitors):
 - 11. Religion.
 - 12. Main Language.
 - (d) For persons whose main language is not English (except visitors):
 - 13. English language fluency.
