CIVIL AVIATION ACT 2009

**CIVIL AVIATION (AIR NAVIGATION) (AMENDMENT)
REGULATIONS 2016**

In exercise of the powers conferred on him by section 33 of the Civil Aviation Act 2009 and of all other enabling powers, the Minister has made the following Regulations.

Title.

1. These Regulations may be cited as the Civil Aviation (Air Navigation) (Amendment) Regulations 2016.

Commencement.

2. The Regulations shall come into operation on the day of publication.

Amendment of the Civil Aviation (Air Navigation) Regulations 2009.

3. The Civil Aviation (Air Navigation) Regulations 2009 are amended in accordance with the provisions of these Regulations.

Amendment of regulation 2.

4. In regulation 2 after the definition of “BGTW” insert-

““Buffadero Training Area” means the area located on Windmill Hill delineated in red in the plan set out in Schedule 6;”.

Amendment of regulation 16.

5. In regulation 16(5) for “2009” substitute “2014”.

Amendment of regulation 107.

6. In regulation 107-

- (a) in sub-regulation (5)-
 - (i) for “sub-regulation (6)” substitute “sub-regulations (6) and (7)”;
 - (ii) for “2009” substitute “2014”;
- (b) After sub-regulation (6) insert-

“(7) Except where necessary for take-off and landing at either Gibraltar Airport or Buffadero Training Area, or by permission from the Director, a military aircraft shall not be flown-

(a) over the congested areas of Gibraltar or over an open-air assembly of persons at a height less than 300 metres above the highest obstacle within a radius of 600 metres from the aircraft; or

(b) elsewhere other than as specified in paragraph (a), at a height less than 150 metres above the ground water, or 150 metres above the highest obstacle within a radius of 150 metres from the aircraft.”.

New Schedule 6.

7. After Schedule 5 insert-

EXPLANATORY MEMORANDUM

These Regulations replace references to the revoked Rules of the Air 2009 with references to the Rules of the Air 2014 and introduce provisions to regulate the low flying of military aircraft over congested areas in Gibraltar.
