### **CIVIL CONTINGENCIES ACT 2007**

# CIVIL CONTINGENCIES EMERGENCY (CORONAVIRUS) (REQUIREMENTS ON ENTRY INTO GIBRALTAR AND TESTING) (NO.8) (AMENDMENT NO.4) REGULATIONS 2021

In exercise of the powers conferred on her by section 11 of the Civil Contingencies Act 2007, and all other enabling powers, the Minister with responsibility for Civil Contingencies, acting with the consent of the Chief Minister, has made these Regulations-

#### Title.

1. These Regulations may be cited as the Civil Contingencies Emergency (Coronavirus) (Requirements on Entry into Gibraltar and Testing) (No.8) (Amendment No.4) Regulations 2021.

### Commencement.

2. These Regulations come into operation on the date of publication.

### Statement in accordance with section 11(2) of the Act.

- 3. The Minister declares that-
  - (a) there is an outbreak of Coronavirus which on the 11th March 2020 the World Health Organisation (WHO) declared to be a pandemic; at the time of the publication of these Regulations there are more than 266,504,411 confirmed cases globally and more than 5,268,849 people have died; Coronavirus has, to date, reached 235 countries, areas or territories, and it is therefore necessary to take measures to prevent, mitigate and control the spread of Coronavirus in Gibraltar;
  - (b) the conditions in section 12 of the Act are met;
  - (c) these Regulations contain only provisions which are appropriate for the purpose of preventing, controlling or mitigating an aspect or effect of the emergency in respect of which the Regulations are made; and
  - (d) the effect of these Regulations is in due proportion to that aspect or effect of the said emergency.

### Amendment to the Civil Contingencies Emergency (Coronavirus) (Requirements on Entry into Gibraltar and Testing) (No.8) Regulations 2021.

- 4.(1) The Civil Contingencies Emergency (Coronavirus) (Requirements on Entry into Gibraltar and Testing) (No.8) Regulations 2021 are amended in accordance with this regulation.
  - (2) After regulation 4, insert the following regulation—

### "Computation of time.

4A. For the purposes of these Regulations, in the computation of the number of days before or after a person arrives in Gibraltar, a person's date of arrival is deemed to be day 0.".

### (3) In regulation 6–

- (a) in subregulation 1(c), insert "subject to subregulation (1A)," before "take the test"; and
- (b) after subregulation (1), insert the following subregulation—
  - "(1A) Where a person to which this regulation applies is on transit to Spain, the test referred to in subregulation (1)(b) must be taken immediately upon arrival.".

### (4) In regulation 7–

- (a) in subregulation (3)(c), for "on the day of their arrival" substitute "immediately upon their arrival";
- (b) in subregulation (3)(d), for "for 10 days following their arrival into Gibraltar" substitute "until day 10 following their date of arrival into Gibraltar";
- (c) in subregulation (3)(e), for "the tenth day" substitute "day 10"; and
- (d) substitute the following for subregulation (6)–
  - "(6) A fully vaccinated person entering Gibraltar after being in a red list country in the 10 day period preceding their date of arrival into Gibraltar after proving to the satisfaction of an immigration officer that they satisfy one of the conditions in subregulation (2) must
    - (a) self-isolate upon their arrival;

- (b) book a PCR test with a registered nurse, medical practitioner or person authorised in writing by the Director of Public Health to be taken on day 2 following their date of arrival into Gibraltar;
- (c) take the test referred to in paragraph (b) and upon completion continue to self isolate until a person authorised in writing by the Director of Public Health has confirmed a negative test result; and
- (d) take an additional PCR test, provided by a registered nurse, medical practitioner or person authorised in writing by the Director of Public Health, on day 8 following their date arrival into Gibraltar.".

### (5) In regulation 10–

- (a) in subregulation (2), after "7(4)" insert "or in the case of a fully vaccinated person, when they have received confirmation of a negative test result in accordance with regulation 7(6)(c)".
- (b) delete subregulation (3).

### EXPLANATORY MEMORANDUM

These Regulations amend the Civil Contingencies Emergency (Coronavirus) (Requirements on Entry into Gibraltar and Testing) (No.8) Regulations 2021.
