AN ORDINANCE to amend the Civil Jurisdiction and Judgments Ordinance 1993.

ENACTED by the Legislature of Gibraltar.

Title and commencement.

1. This Ordinance may be cited as the Civil Jurisdiction and Judgments Ordinance 1993 (Amendment) Ordinance 1997 and shall come into effect simultaneously with the Civil Jurisdiction and Judgments Ordinance 1993.

Amendments to the Civil Jurisdiction and Judgments Ordinance 1993.

2.(1) The Civil Jurisdiction and Judgments Ordinance 1993 shall be amended in accordance with the provisions of this section.

(2) Section 3 shall be amended as follows -

- (a) after the reference “3.” there shall be inserted the reference “(1)”; and
- (b) after subsection (1) there shall be inserted the following subsection -

“(2) A court of law shall have regard to, but shall not be bound by, the principles laid down by and in any relevant decision of the European Court, in determining any question as to the meaning or effect of any provision of the Brussels Convention for the purposes of this section.”.

(3) Section 5 shall be amended by inserting the following subsection after subsection (5) -

“(6) Nothing in this section shall prejudice the provisions of section 3(2) above.”.

(4) For Schedules 1 and 2, there shall be substituted the Schedules 1 and 2 annexed to Legal Notice No. 61 of 1995.

(5) Schedule 3 shall be amended as follows -

- (a) Article 35 shall be amended by deleting all words appearing after the words “Article 35”; and
- (b) Article 36 shall be amended by deleting all words appearing after the words “Article 36”.

Applicability of Legal Notices No. 61 and 70 of 1995.

3. For the avoidance of doubt, and without prejudice to the provisions of section 2(4) above, Legal Notice No. 61 of 1995 and Legal Notice No. 70 of 1995 shall be of no legal effect.
