AN ACT to amend the Civilians Registration Act.

ENACTED by the Legislature of Gibraltar.

Title and commencement.

1. This Act may be cited as the Civilians Registration (Amendment) Act 1993 and shall come into effect on such day as the Governor may by notice in the Gazette, appoint and different days may be so appointed for different purposes.

Amendment to section 2.

2. Section 2 of the Civilians Registration Act (hereinafter called "the principal Act") is amended-

- (a) by inserting after the figure "2" the figure "(1)";
- (b) in the definition of "civilian", by omitting the words "not being a member of Her Majesty's Forces or of a class prescribed" and substituting therefor the words "defined in Schedule 1";
- (c) by inserting a new sub-section (2) as follows-

"(2) Registration under this Act prior to a date specified by the Governor by notice in the Gazette for this purpose, shall not constitute registration for the purposes of this Act twelve months after the date so specified by the Governor. ";

- (d) by inserting a new sub-section (3) as follows-

"(3) Where reference is made in this Act to a "card", the reference-

(a) in the case of a person specified in Schedule 1 as being entitled to an identity card, shall be to an identity card; and

(b) in the case of a person specified in Schedule 1 as being entitled to a civilian registration card, shall be to a civilian registration card,

and such card when issued, shall remain the property of the Government. "

Amendment to section 3.

3. Section 3 of the principal Act is amended-

- (a) in sub-section (1) by omitting all the words after "Gibraltar" and substituting therefor the following words-

"and-

(a) any such civilian shall register in accordance with the provisions of this Act; and

(b) there shall be recorded in the register such particulars with respect to the matters specified in Schedule 2 as may be prescribed.";

(b) in sub-section (2) by omitting the words "any item in the Schedule" and substituting therefor the words "by notice in the Gazette the Schedules.";

(c) by omitting sub-section (3).

Repeal and replacement of section 4.

4. Section 4 of the principal Act is repealed and replaced by the following section-

"4. The Administrative Secretary may, from time to time, appoint a fit and proper person to be the registration officer who shall make all such arrangements and do all such things as are necessary for the maintenance of the register in accordance with the provisions of this Act. "

Amendment to section 6.

5. Section 6 of the principal Act is amended-

(a) by omitting the marginal note thereto and substituting therefor the new marginal note-

"Cards" ;

(b) in sub-section (1)-

(i) by omitting the words "(hereinafter in this Act referred to as an identity carnet)";

(ii) by omitting the final fullstop and substituting therefor a colon and the following proviso-

"Provided that such card shall only be issued to a person being less than 15 years old at the time of issue with the consent of and at the request of the parent or guardian of that person.";

- (c) by omitting sub-section (2) and substituting therefor the following new sub-section-

"(2) The card shall be in the form prescribed by regulation.";

- (d) in sub-section (3)-

(i) by omitting the word "Governor" and substituting therefor the words "Registration Officer";

(ii) by omitting the words "identity carnet" and substituting therefor the word "card".

Amendment to section 7.

6. Section 7 of the principal Act is amended in sub-section (1) by-

- (a) omitting in paragraphs (b), (e) and (g) the words "the Schedule" and substituting therefor the expression "Schedule 2";
- (b) omitting wherever they appear, the words "identity carnet" and substituting therefor the word "card";
- (c) omitting in paragraph (j) the words "identity carnets" and "camets" and substituting therefor the word "cards";
- (d) omitting paragraph (1) and substituting therefor the following new paragraph-

"(1) for the period for which a card is valid.".

Amendment to section 8.

7. Section 8 of the principal Act is amended-

- (a) in sub-section (1) by omitting the words "identity carnet" wherever they appear and substituting therefor the word "card";
- (b) in sub-section (2) by omitting in paragraph (ii) the word "Governor" and substituting therefor the words "Registration Officer";
- (c) in sub-section (4) by-
 - (i) in paragraph (a) omitting the expression "of ;E5" and substituting therefor the expression "at level 3 on the standard scale";
 - (ii) in paragraph (b) (i) by omitting the expression "of £50" and substituting therefor the expression "at level 4 on the standard scale";
 - (iii) in paragraph (b) (ii) by omitting the expression "of £100".

New Schedule 1.

8. The principal Act is amended by inserting a new Schedule 1 as follows-

"SCHEDULE 1

Section 2

Civilians and entitlement to cards.

1. An individual shall be a civilian for the purposes of this Act if he is-

- (a) a British Dependent Territory citizen by virtue of a connection with Gibraltar; or
- (b) registered under the Gibraltarian Status Act; or
- (c) a British citizen with a right of permanent residence in Gibraltar; or

(d) an individual, who is not a visitor, entitled to be resident in Gibraltar and present in Gibraltar, subject to such conditions and for such periods as may be specified.

2. An individual falling within sub-paragraphs (a), (b) or (c) of paragraph 1, shall, on registration, be issued with an identity card.

3. An individual falling within sub-paragraph (d) shall, on registration, be issued with a civilian registration card."

Amendment to Schedule.

9. The Schedule to the Act is redesignated as Schedule 2 and is amended by omitting everything after the heading thereto and substituting therefor the following-

"1. Application for an identity card.
