**COMPANIES ORDINANCE.**

**COMPANIES ORDINANCE (AMENDMENT TO SCHEDULE)  
ORDER, 1993.**

In exercise of the powers conferred on him by section 313 of the Companies Ordinance and of all other enabling powers, the Governor has made the following order-

**Title and commencement.**

1. This order may be cited as the Companies Ordinance (Amendment to Schedule) Order 1993 and shall come into effect on the 10th day of June, 1993.

**Amendment to Schedule 8.**

2. Schedule 8 to the Companies Ordinance is amended in the table of fees by-

- (a) in item (g) inserting after the words "Annual Return" the words "or substitution of an annual return after the due date for filing of that return";
- (b) in item (h) inserting in paragraphs (ii) and (iii) after the word "microfiche" the words "or electronic archive";
- (c) in item (i) inserting in paragraph (ii) and (iii) after the words "microfiche" the words "or electronic archive";
- (d) in item (k) -
  - (i) omitting the words "(produced from microfiche record)" and substituting therefor the following words-

"(i) produced from microfiche or electronic archive record";

(ii) by inserting after paragraph (i), as now so numbered, the following words-

"(ii) produced from microfiche or electronic archive record within the day £20 per document";

(e) in item (1) by omitting the words and substituting therefor the following words-

"Lodging any document required to be given, delivered, sent or forwarded to, or lodged or filed with the Registrar (except where otherwise specified) or to lodge a substitute document for a document lodged or filed in the register (other than an annual return after the due date for filing of that return)";

(f) in item (m) by-

(i) inserting after the letter "(m)" the figure "(i)";

(ii) by inserting the following new paragraphs-

"(ii) the fee prescribed under section 80(1) for entry in the register of charges and issue of certificate of registration of charge  
£30

(iii) entry of memorandum of satisfaction under section 82 £ 5

(iv) certificate of discharge under section 82 £15";

(g) by omitting item (o) and substituting therefor the following new item-

"(o) same day urgency fee for incorporation or registration of a company under Part IX (including

registration) (correct documents to be lodged with the Registrar before 12.00 midday) £100";

- (h) by omitting item (p) and substituting therefor the following new item -

"(p) same day urgency fee for registration of change of name of a company (correct documents to be lodged with the Registrar before 12.00 midday) £100";

- (i) in item (q) by inserting after the word "microfiche" the words "or electronic archive";
- (j) in item (s) by inserting after the word "microfiche" the word "or electronic archive",

and the Schedule to this order incorporating those amendments replaces the table of fees in Schedule 8.
