COMPANIES ACT (SCHEDULE 24) REGULATIONS 2017

In exercise of the powers conferred on him by section 426 of the Companies Act, and all other enabling powers, the Minister has made the following Regulations-

Title.

1. These Regulations may be cited as the Companies Act (Schedule 24) Regulations 2017.

Commencement.

2. These Regulations come into operation on the 1 January 2018.

Amendment of fees (section 426).

- 3. Section 426(4) of the Companies Act 2014 is amended as follows-

 - (g) in paragraph (c) for "£15.00" substitute "£17.50".
