COMPANIES ACT 2014

COMPANIES ACT (FEES) (AMENDMENT) REGULATIONS 2021

In exercise of the powers conferred upon him by section 426 of the Companies Act 2014, and all other enabling powers, the Minister has made the following Regulations-

Title.

1. These Regulations may be cited as the Companies Act (Fees) (Amendment) Regulations 2021.

Commencement.

2. These Regulations shall come into operation on 1st January 2022.

Amendment of the fees in section 426 of the Companies Act 2014.

3. Section 426(4) of the Companies Act 2014 is amended as follows-

(a) in paragraph (a)-

(i) in subparagraph (i) for “£36.50” substitute “£40.00”;

(ii) in subparagraph (ii) for “£71.50” substitute “£80.00”;

(iii) in subparagraph (iii) for “£106.50” substitute “£120.00”;

(iv) in subparagraph (iv) for “£141.50” substitute “£160.00”;

(b) in paragraph (b)-

(i) in subparagraph (i) for “£58.50” substitute “£100.00”;

(ii) in subparagraph (ii) for “£117.00” substitute “£150.00”; and

(c) in paragraph (c) for “£17.50” substitute “£20.00”.

Amendment of Schedule 24 to the Companies Act 2014.

4. Schedule 24 to the Companies Act 2014 is amended as follows-

- (a) in paragraph 1(c) for “£585.00” substitute “£620.00”;
- (b) in paragraph 1(d) for “£200.00” substitute “£210.00”;
- (c) in paragraph 1(g)-
 - (i) for “£86.00” substitute “£91.00” in the two places where it occurs;
 - (ii) for “£150.00” substitute “£160.00”;
 - (iii) for “£250.00” substitute “£265.00”;
 - (iv) for “£500.00” substitute “£525.00”;
 - (v) for “£117.00” substitute “£200.00”;
- (d) in paragraph 1(h) for “£17.50” substitute “£20.00”
- (e) in paragraph 1(i) for “£17.50” substitute “£20.00”;
- (f) in paragraph 1(j) –
 - (i) for “£105.00” substitute “£110.00”;
 - (ii) for “£58.50” substitute “£62.00”;
- (g) in paragraph 1(k) for “£17.50” substitute “£25.00”;
- (h) in paragraph 1(l) for “£87.75” substitute “£92.00”;
- (i) in paragraph 1(m) for “£35.00” substitute “£37.00”;
- (j) in paragraph 1(p) for “£52.50” substitute “£55.00”;
- (k) in paragraph 1(q)-
 - (i) for “£17.50” substitute “£20.00” in both places where it occurs;
 - (ii) for “£23.50” substitute “£25.00”;
 - (iii) in subparagraphs (ii)(dd) and (ee) for “£50.00” substitute “£55.00”;
 - (iv) in subparagraph (ii)(ff) for “£75.00” substitute “£80.00”; and
- (l) in paragraph 1(r) for “£300.00” substitute “£315.00”.
