In exercise of the powers conferred upon him by section 82 of the Education and Training Act, and all other enabling powers, the Minister has made the following Regulations—

Title.

1. These Regulations may be cited as the Education (Gibraltar Qualified Teacher Status) Regulations 2020.

Commencement.

2. These Regulations come into operation on the day of publication.

Interpretation.

- 3. In these regulations, unless the context otherwise requires—
 - "EYTS" means Early Years Teacher Status awarded by the Department for Education in the United Kingdom;
 - "GQTS" means Gibraltar Qualified Teacher Status;
 - "GQTS Certificate" means a certificate issued under regulation 6;
 - "GQTS Register" means the register established under regulation 5;
 - "QTLS" means Qualified Teacher Learning and Skills status awarded by The Society for Education and Training in England;
 - "QTS" means Qualified Teacher Status awarded by the Teaching Regulation Agency in England.

Requirement to Register.

4. No person shall work as a teacher in a school operated by the Department of Education unless registered in the GQTS Register.

Register.

- 5.(1) The Director shall cause to be established and maintained a register containing the particulars listed in Schedule 2 of all persons awarded GQTS.
- (2) All persons registered in the GQTS Register shall be awarded a GQTS number.

(3) The Director may consider applications for registration in such a form and manner as the Director may determine.

Certificate.

- 6.(1) Subject to sub-regulations (2) and (3), all persons entered in the GQTS Register shall be issued with a certificate in the form set out in the Schedule 3.
- (2) Where a person entered in the GQTS Register under regulation 7(c) below does not hold QTS but holds EYTS, the Director shall issue a GQTS Certificate in the form set out in Schedule 4.
- (3) Where a person entered in the GQTS Register under regulation 7(c) below does not hold QTS but holds QTLS, the Director shall issue a GQTS Certificate in the form set out in Schedule 5.

Persons to be Registered

- 7. The following persons shall be registered in the GQTS Register–
 - (a) a person who has been awarded QTS;
 - (b) a person who has obtained a Post Graduate Certificate in Education from an institution listed in Schedule 1; and
 - (c) a person who was employed by the Department of Education as a teacher in Gibraltar prior to the commencement of these regulations.
