AN ORDINANCE to amend the Employment Ordinance and the Employment (Amendment) Ordinance 1992.

ENACTED by the Legislature of Gibraltar.

Title and Commencement.

1. This Ordinance may be cited as the Employment Ordinance (Amendment)(No.2) Ordinance 2001 and shall come into force on such date as the Government may appoint by notice in the Gazette.

Amendments of the Employment Ordinance and subsidiary legislation.

- 2.(1) The Employment and Training Ordinance shall be amended in accordance with the provisions of this section.
- (2) The long title shall be amended by deleting the words "and training".
- (3) Section 2 shall be amended by inserting in the appropriate place the following definition—
 - "Minister" means the Minister with responsibility for employment.
- (4) Section 2 shall be amended by adding to the definition of "conditions of employment" the words "redundancy compensation" after the word "wages" in the first line.
- (5) Section 2 shall be amended by deleting the definition of "Director" and substituting in its place the following definition—
 - "Director" means the Director of Employment, or such other public officer as the Minister may designate to administer the provisions of this Ordinance;".
- (6) Sections 3 to 5 are repealed.
- (7) All references to the word "Governor" whenever it appears in the Employment Ordinance and in subsidiary legislation made thereunder shall be substituted with the word "Minister".
- (8) Section 36 shall be amended by adding a new sub-section (3), as follows-
 - "(3) Notwithstanding any other provision of this Ordinance, the Minister may make such orders as he thinks fit to make provision in relation to conditions of employment.".

- (9) Section 38(1) shall be amended by deleting the words "and Spanish".
- (10) Section 86(1) shall be amended as follows-
 - (a) in paragraph (a), be deleting the words "and training";
 - (b) paragraph (f) and subsection (2) shall be omitted.
- (11) Section 4(2) of the Employment Ordinance (Amendment) Ordinance 1992 is repealed.
- (12) The Industrial Tribunal Rules shall be amended in rules 14(4) and 18 by substituting for the words "Department of Labour and Social Security" the words "Ministry of Employment".
