# REGULATION OF WAGES AND CONDITIONS OF EMPLOYMENT ORDINANCE.

(Cap. 139).

## CONDITIONS OF EMPLOYMENT (ANNUAL AND PUBLIC HOLIDAYS) (AMENDMENT) ORDER, 1985.

In exercise of the powers conferred on him by Section 8 of the Regulation of Wages and Conditions of Employment Ordinance, and of all other enabling powers, the Governor having received a conditions of employment recommendation from the Regulation of Conditions of Employment Board has made the following order:

#### Title and commencement.

- $1.\,(1)$  This order may be cited as the Conditions of Employment (Annual and Public Holidays) (Amendment) Order, 1985.
- (2) This order shall be deemed to have come into operation on the 1st day of January, 1985.

#### Amendment of Booklet 5 of Cap. 139

2. Paragraph 4(1) of the Conditions of Employment (Annual and Public Holidays) Order is amended by omitting Tables I, II and III thereof and substituting therefor the following new Tables:
