*In exercise of the powers conferred on it by section 19 of the European Economic Interest Grouping Act, and all other enabling powers, the Government has made the following Regulations—*

**Title and commencement.**

1. These Regulations may be cited as the European Economic Interest Grouping (Fees) Regulations 2013 and come into operation on 1 January 2014.

**Fees payable to the Registrar.**

2. The fees specified in the Schedule to these Regulations shall be payable to the Registrar in respect of the matters so specified.
