CROSS-BORDER MEDIATION (EU EXIT) REGULATIONS 2020

In exercise of the powers conferred upon her by section 11 and paragraph 1 of Schedule 3 of the European Union (Withdrawal) Act 2019, the Minister has made the following Regulations-

Title.

1. These Regulations may be cited as the Cross-Border Mediation (EU Exit) Regulations 2020.

Commencement.

2. These Regulations come into operation on 1 January 2021.

Revocation of Part XIA of the Supreme Court Act.

EXPLANATORY MEMORANDUM

These Regulations are made in exercise of the powers in section 11 of the European Union (Withdrawal) Act 2019 in order to address failures of retained EU law to operate effectively and other deficiencies arising from the withdrawal of the United Kingdom from the European Union.

These Regulations revoke the domestic law provisions giving effect to Directive 2008/52/EC of the European Parliament and of the Council of 21 May 2008 on certain aspects of mediation in civil and commercial matters ("the Mediation Directive").

These Regulations make transitional and saving provisions to ensure that the relevant domestic legislation will continue to apply to EU cross-border mediations that started before 1 January 2021.
