1. This Order may be cited as the Exchange Control (Miscellaneous Provisions) Order.

Bankruptcy notice.

- 2. Any bankruptcy notice issued in accordance with any rules relating to bankruptcy from time to time in force at the request of a person residing outside the scheduled territories as defined in Schedule 1 to the Act being a creditor for an amount due under a judgment, order or award shall, with such variations as circumstances may require
 - (a) in a case in which permission of the Financial and Development Secretary has not been obtained for payment of the amount due, be in the form set out in Part I of the Schedule to this Order;
 - (b) in a case in which permission of the Financial and Development Secretary for payment into a blocked account has been obtained, be in the form set out in Part II of the Schedule to this Order.

Prescribed court.

3. The court prescribed for the purposes of paragraph 4 of Schedule 4 to the Act, is the Supreme Court.

Police officers.

4. Every police officer not below the rank of inspector is authorized to act for the purposes of paragraph 2 of Part I of Schedule 5 to the Act.
