# EXPORT CONTROL (SANCTIONS ETC.) (AMENDMENT) ORDER 2011

In exercise of the powers conferred upon him by sections 3, 4, 5, 6, 7 and 9 of the Export Control Act 2005, and all other enabling powers, the Minister has made the following Order–

#### Title and commencement.

1. This Order may be cited as the Export Control (Sanctions etc) (Amendment) Order 2011 and comes into operation on the day of publication.
