**EXPORT CONTROL (SANCTIONS ETC.)
(AMENDMENT NO.2) ORDER 2014**

In exercise of the powers conferred upon him by sections 3, 4, 5, 6, 7 and 9 of the Export Control Act 2005, and all other enabling powers, the Minister for the purposes of implementing Council Decision 2014/727/CFSP of 20 October 2014 amending Decision 2011/137/CFSP concerning restrictive measures in view of the situation in Libya has made the following Order–

Title and commencement.

1. This Order may be cited as the Export Control (Sanctions etc.) (Amendment No.2) Order 2014 and comes into operation on the day of publication.

Amendments to Schedule 4 of the Export Control (Sanctions etc.) Order 2006.

2. Schedule 4 to the Export Control (Sanctions etc.) Order 2006 is amended after the heading–

“LIBYA

2011”**
