EXPORT CONTROL (SANCTIONS ETC.) (No.5) ORDER 2015

In exercise of his powers under sections 3, 4, 5, 6 and 7 of the Export Control Act 2005, the Minister has made the following Order for the purposes of implementing Corrigendum to Council Implementing Regulation (EU) No.740/2014 of 8 July 2014 implementing Regulation (EC) No 765/2006 concerning restrictive measures in respect of Belarus and Council implementing Regulation (EU) 2015/1133 of 13 July 2015 implementing Regulation (EC) No 765/2006 concerning restrictive measures against Belarus—

Title and commencement.

1. This Order may be cited as the Export Control (Sanctions etc.) (No.5) Order 2015 and comes into operation on the day of publication.
