In exercise of the powers conferred upon him by sections 3, 4, 5, 6, 7 and 9 of the Export Control Act 2005, and all other enabling powers, and for the purposes of implementing Council Implementing Regulation (EU) 2016/466 of 31 March 2016, implementing Article 21(2) of Regulation (EU) 2016/44 concerning restrictive measures in view of the situation in Libya, the Minister has made the following Order—

Title.

1. This Order may be cited as the Export Control (Sanctions etc.) (Amendment No.11) Order 2016.

Commencement.

2. This Order comes into operation on the day of publication.

Amendment to Schedule 4 of the Export Control (Sanctions etc.) Order 2006.

3. Schedule 4 of the Export Control (Sanctions etc.) Order 2006 is amended after the heading "LIBYA" by adding the following persons to the list of persons below the heading "COUNCIL REGULATION (EU) 2016/44–ANNEX III"–
