EXPORT CONTROL (SANCTIONS ETC.) (AMENDMENT NO.9) ORDER 2016

In exercise of the powers conferred upon him by sections 3, 4, 5, 6, 7 and 9 of the Export Control Act 2005, and all other enabling powers, for the purpose of implementing Council Implementing Regulation (EU) 2016/276 and Council Regulation (EU) 2016/277 of 25 February 2016 amending Regulation (EC) No 765/2006 concerning restrictive measures in respect of Belarus, the Minister has made the following Order—

Title.

1. This Order may be cited as the Export Control (Sanctions etc) (Amendment No.9) Order 2016.

Commencement.

2. This Order comes into operation on the day of publication.
