**EXPORT CONTROL (SANCTIONS ETC.) ORDER 2006**

**EXPORT CONTROL (SANCTIONS ETC.) (AMENDMENT NO.16)  
ORDER 2016**

In exercise of the powers conferred upon him by sections 3, 4, 5, 6, 7 and 9 of the Export Control Act 2005 and all other enabling powers, the Minister has made the following Order for the purposes of implementing Council Implementing Regulation (EU) 2016/1334 of 4 August 2016 implementing Article 21(2) of Regulation (EU) 2016/44 concerning restrictive measures in view of the situation in Libya—

**Title.**

1. This Order may be cited as the Export Control (Sanctions etc.) (Amendment No.16) Order 2016.

**Commencement.**

2. This Order shall come into operation on the day of publication.

**Amendment to Schedule 4 of the Export Control (Sanctions etc.) Order 2006.**

3. Schedule 4 of the Export Control (Sanctions etc.) Order 2006 is amended after the heading “**LIBYA**” in the following manner—

(a) after the heading “COUNCIL REGULATION (EU) 2016/44 ANNEX III ” substitute the entries for “SALEH ISSA GWAIDER, Agila” and “GHWELL, Khalifa” with—
