### **TUNISIA SANCTIONS (AMENDMENT NO.1) ORDER 2017**

In exercise of the powers conferred upon him by sections 3 and 7 of the Export Control Act 2005 and section 3(g)(i) of the Interpretation and General Clauses Act and for the purpose implementing Council Regulation (EU) No 2017/149 of 27 January 2017 implementing Regulation (EU) No 101/2011 of 4 February 2011 concerning restrictive measures directed against certain persons, entities and bodies in view of the situation in Tunisia, the Minister has made the following Order-

## Title.

1. This Order may be cited as the Tunisia Sanctions (Amendment) (No.1) Order 2017.
