## **UKRAINE (SANCTIONS) (NO 2) ORDER 2014**

# **NOTICE OF AMENDMENT (No.19)**

In exercise of the powers conferred upon me by paragraph 3(4) of the Ukraine Sanctions Order 2014, I have issued the following Notice-

The Ukraine (Sanctions) (No.2) Order 2014 is amended as follows-

(a) by inserting the following after "paragraph 7"-

#### "Article 6A.

- 7A. By way of derogation from Article 2(2), a Member State may authorise payments to the Crimean Sea Ports for services provided at the ports of Kerch Fishery Port, Yalta Commercial Port and Evpatoria Commercial Port, and services provided by Gosgidrografiya and by Port-Terminal branches of the Crimean Sea Ports.";
- (b) In the Schedule-
