## EXPORT CONTROL ACT 2005

### EXPORT CONTROL (SANCTIONS ETC.) (AMENDMENT NO.24) ORDER 2018

In exercise of the powers conferred upon him by sections 3,4,5,6, 7 and 9 of the Export Control Act 2005 and all other enabling powers, the Minister has made the following Order for the purposes of implementing Commission Implementing Regulation (EU) 2018/126 of 24 January 2018 amending Council Regulation (EU) 2016/44 concerning restrictive measures in view of the situation in Libya-

#### **Title.**

1. This Order may be cited as the Export Control (Sanctions etc.) (Amendment No.24) Order 2018.

#### **Commencement.**

2. This Order comes into operation on the day of publication.

#### **Amendment to Schedule 4 of the Export Control (Sanctions etc.) Order 2006.**

3. Schedule 4 of the Export Control (Sanctions etc.) Order 2006 is amended after the heading "**LIBYA**" and after the headings "**ANNEX V**" "**LIST OF VESSELS REFERRED TO IN POINT (H) OF ARTICLE 1 AND ARTICLE 15 AND APPLICABLE MEASURES AS SPECIFIED BY THE SANCTIONS COMMITTEE**" by substituting the entry for "**CAPRICORN**" with-

1. Name: CAPRICORN

Listed pursuant to paragraphs 10(a) and 10(b) of resolution 2146 (2014), as extended and modified by paragraph 2 of resolution 2362 (2017) (prohibition to load, transport or discharge; prohibition to enter ports). Pursuant to paragraph 11 of resolution 2146, this designation was renewed by the Committee on 18 January 2018 and is valid until 17 April 2018, unless

terminated earlier by the Committee pursuant to paragraph 12 of resolution 2146. Flag State: unknown.

**Additional information**

Listed on 21 July 2017. IMO: 8900878. As of 21 September 2017, the vessel was located in international waters off the United Arab Emirates.”.
