Title.

1. This Order may be cited as the Export Control (Sanction Etc.) (Amendment No.38) Order 2019.

Commencement.

2. This Order comes into operation on the day of publication.

Amendment to Schedule 4 of the Export Control (Sanctions etc.) Order 2006.

- 3. Schedule 4 to the Export Control (Sanctions etc.) Order 2006 is amended after the heading "ZIMBABWE" in the following manner-
