## FINANCIAL SERVICES (INVESTMENT AND FIDUCIARY SERVICES) ACT

### FINANCIAL SERVICES (ALTERNATIVE INVESTMENT FUND MANAGERS) (FEES) (AMENDMENT) REGULATIONS 2015

In exercise of the powers conferred upon him by sections 53 and 56 of the Financial Services (Investment and Fiduciary Services) Act, and all other enabling powers, the Minister has made the following Regulations—

#### Title and commencement.

1. These Regulations may be cited as the Financial Services (Alternative Investment Fund Managers) (Fees) (Amendment) Regulations 2015 and come into operation on the 1<sup>st</sup> day April 2015.

### Amendment to the Financial Services (Alternative Investment Fund Managers) (Fees) Regulations 2013.

- 2. The Financial Services (Alternative Investment Fund Managers) (Fees) Regulations 2013 are amended as follows—
  - (a) Substitute subregulation (2) of regulation 8 with the following subregulation—
    - "(2) An annual fee must be paid in advance and in any event within 28 days from 1<sup>st</sup> April in any financial year unless the Commission agrees otherwise."
  - (b) In PART 1 of the Schedule, substitute the Table with the following Table-
