AN ORDINANCE to amend the Firearms Ordinance.

ENACTED by the Legislature of Gibraltar.

Title.

1. This Ordinance may be cited as the Firearms (Amendment) Ordinance, 1990.

Amendment to Section 3.

2. Section 3 of the Firearms Ordinance (hereinafter referred to as "the principal Ordinance") is amended in sub-section (2)(b) by omitting the figure "£100" and substituting therefor the figure "£1,000".

Amendment to Section 4.

3. Section 4 of the principal Ordinance is amended as follows—

- (a) in sub-section (9) by omitting the figure "£20" and substituting therefor the figure "£ 100";
- (b) in sub-section (10) by omitting the figure "£20" and substituting therefor the figure "£ 1,000".

Amendment to Section 5.

4. Section 5 of the principal Ordinance is amended—

- (a) in subsection (1)(a) by omitting the figure "£5" and substituting therefor the figure "£20";
- (b) in subsection (1) (b) by omitting the figure "£3" and substituting therefor the figure "£15";
- (c) in subsection (1)(c) by omitting the figure "£2" and substituting therefor the figure "£10".

Amendment to Section 6.

5. Section 6 of the principal Ordinance is amended—

- (a) in subsection (4)(a) by inserting the words "reasonably necessary for the protection" after the word "equipment";
- (b) in sub-section (12) by omitting the figure "£20" and substituting therefor the figure "£500".

Amendment to Section 8.

6. Section 8 of the principal Ordinance is amended in sub-section (3) by omitting the figure "£20" and substituting therefor the figure "£1,000".

Amendment to Section 9.

7. Section 9 of the principal Ordinance is amended in sub-section (2) by omitting the figure "£20" and substituting therefor the figure "£1,000".

Amendment to Section 10.

8. Section 10 of the principal Ordinance is amended—

- (a) in subsection (2) by omitting the figure "£40" and substituting therefor the figure "£50";
- (b) in subsection (6) by omitting the figure "£20" and substituting therefor the figure "£1,000".

Amendment to Section 11.

9. Section 11 of the principal Ordinance is amended—

- (a) in sub-section (2)(c) by omitting the figure "£3" and substituting therefor the figure "£50";
- (b) in sub-section (4) by omitting the figure "£20" and substituting therefor the figure "£500".

Amendment to Section 12.

10. Section 12 of the principal Ordinance is amended in sub-section (5) by omitting the figure "£20" and substituting therefor the figure "£100".

Amendment to Section 13.

11. Section 13 of the principal Ordinance is amended in sub-section (4) by omitting the figure "£20" and substituting therefor the figure "£1,000".

Amendment to Section 14.

12. Section 14 of the principal Ordinance is amended in sub-section (4) by omitting the figure "£20" and substituting therefor the figure "£1,000".

- (a) in sub-section (3) by—
 - (i) omitting the figure '£100" and substituting therefor the figure "£1,000";
