SCHEDULE.

Standard metal composition or fineness, diameter and weight of Gibraltar commemorative ECU coins.

AN ACT TO AUTHORIZE THE ISSUE OF ECU COINS BY THE GOVERNMENT OF GIBRALTAR, TO PROVIDE FOR SUCH COINS TO BE LEGAL TENDER FOR PAYMENTS OF THE AMOUNTS SPECIFIED AND FOR MATTERS INCIDENTAL THERETO.

Title and commencement.

1. This Act may be cited as the Gibraltar Coinage (ECU) Act, 1990 and shall come into operation on such date as the Governor may by notice in the Gazette appoint.

Interpretation.

2. In this Act-

"ECU" means the monetary unit of the European Economic Communities and shall have the exchange value prescribed for it by that body from time to time.

Issue of Gibraltar ECU coinage.

- 3.(1) Subject to subsection (2), the Minister responsible for finance may by notice in the Gazette authorise the issue of ECU coins (hereinafter referred to as "coins") of such denominations, design, composition, weight and dimensions as shall be specified in that notice.
- (2) The design of such coins shall have been approved by the Minister responsible for finance prior to their issue in accordance with subsection (1).

Standard of coins.

- 4.(1) All coins shall be of the standard weight, diameter and composition set out in the Schedule to this Act.
- (2) In the making of the coins a remedy (that is to say a variation from the standard weight, composition or dimensions so specified) may he allowed in the notice referred to in Section 3. such variation not to exceed the appropriate remedy allowance set out in the said Schedule.

Legal tender.

5. The coins shall be legal tender in Gibraltar for payment of an amount of not less than £2,000.

Minister responsible for finance's power to vary Schedule.

6. The Minister responsible for finance may by notice in the Gazette vary, add to, or delete, any provisions of the Schedule to this Act.

Demonetisation.

7. The Minister responsible for finance may make rules for the demonetisation of coins issued under this Act.

Consequential amendments.

- 8.(1) Section 5 of the Coinage Act 1870 shall have no effect with respect to any coins issued in pursuance of this Act.
- (2) Section 222 of the Criminal Offences Act is amended
 - (a) in paragraph (b) by inserting after the expression "or in pursuance of the Gibraltar Coinage Act 1990," the expression "or in pursuance of the Gibraltar Coinage (ECU) Act, 1990"; and
 - (b) in paragraph (f) by inserting after the expression "Gibraltar Coinage Act 1990," the expression "or in any notice made under section 3 of the Gibraltar Coinage (ECU) Act, 1990,".
