GIBRALTAR COINAGE ACT, 1990.

ISSUE OF COINS TO COMMEMORATE THE 40th ANNIVERSARY OF THE CORONATION OF QUEEN ELIZABETH II NOTICE 1993.

In exercise of the powers conferred on him by section 2 of the Gibraltar Coinage Act 1990, and of all other enabling powers, the Governor has issued the following notice-

Title.

1. This notice may be cited as the Issue of Coins to Commemorate the 40th Anniversary of the Coronation of Queen Elizabeth II Notice 1993.

Issue of new coins.

2.(1) New coins of platinum, gold, silver and cupro nickel in the denomination of a Crown and denominations thereof shall be made.

(2) In the making of the said coins, the millesimal fineness or composition of metals, diameters, shapes and other specifications shall be as set out in Part II of the Schedule to the Gibraltar Coinage Act 1990.

(3) In the making of the said coins, a remedy (that is a variation from the standard weight) shall be allowed as set out in the said Part of the Schedule.

Design of the coins.

3. The design of the coins authorised by this notice shall be as follows-

- (a) each coin shall bear on the obverse impression the effigy designed by Arnold Machin of Her Majesty Queen Elizabeth II with the inscription "ELIZABETH II" to the left and the inscription "GIBRALTAR" and the date of the year to the right;
- (b) the reverse impression shall bear the design of-

(i) a portrait of Queen Anne with the inscription "HOUSE OF STUART. QUEEN ANNE. 1702-1714" and the value of the coin; or

(ii) a portrait of King George I with the inscription "HOUSE OF HANOVER. KING GEORGE I. 1714-1727" and the value of the coin; or

(iii) a portrait of King George II with the inscription "HOUSE OF HANOVER. KING GEORGE II. 1727-1760" and the value of the coin; or

(iv) a portrait of King George III with the inscription "HOUSE OF HANOVER. KING GEORGE III. 17601820" and the value of the coin; or

(v) a portrait of King George IV with the inscription "HOUSE OF HANOVER. KING GEORGE IV. 18201830" and the value of the coin; or

(vi) a portrait of King William IV with the inscription "HOUSE OF HANOVER. KING WILLIAM IV. 18301837" and the value of the coin; or

(vii) a portrait of Queen Victoria with the inscription "HOUSE OF HANOVER. QUEEN VICTORIA. 1837-1901" and the value of the coin; or

(viii) a portrait of King Edward VII with the inscription "HOUSE OF SAX-COBURG. KING EDWARD VII 1901-1910" and the value of the coin; or

(ix) a portrait of King George V with the inscription "HOUSE OF WINDSOR. KING GEORGE V. 1910-1936" and the value of the coin; or

(x) a portrait of King Edward VIII with the inscription "HOUSE OF WINDSOR. KING EDWARD VIII 1936" and the value of the coin; or GIBRALTAR GAZETTE, No. 2,722, Thursday 29th April, 1993.

(xi) a portrait of King George VI with the inscription "HOUSE OF WINDSOR. KING GEORGE VI. t936-1952" and the value of the coin; or

(xii) a portrait of Queen Elizabeth II wearing the coronation crown with the inscription "40th ANNIVERSARY OF THE CORONATION OF QUEEN ELIZABETH II. JUNE 2nd 1953" and the value of the coin.

Legal tender.

4. The said coins shall be current and legal tender in Gibraltar.
