GIBRALTAR COINAGE ACT 1990

ISSUE OF TRADERS OF THE WORLD COIN NOTICE 1995

In exercise of the powers conferred on him by section 2 of the Gibraltar Coinage Act 1990 and of all other enabling powers, the Governor has issued the following notice -

Title.

1. This notice may be cited as the Issue of Traders of the World Coin Notice 1995.

Issue of new coins.

- 2.(1) New coins of platinum, gold, silver and cupro nickel in the denomination of a Crown and denominations thereof, shall be made.
- (2) In the making of the said coins, the millesimal fineness or composition of metals, diameters, shapes and other specifications shall be as set out in Part II of the Schedule to the Gibraltar Coinage Act 1990.
- (3) In the making of the said coins, a remedy (that is, a variation from the standard weight) shall be allowed as set out in the said Part of the Schedule.

Design of the coins.

- 3. The design of the coins authorised by this notice shall be as follows -
 - (a) the coins shall bear on the obverse impression the effigy of Her Majesty Queen Elizabeth II with the inscription "ELIZABETH" to the left and the inscription "GIBRALTAR" and the date of the year to the right;
 - (b) the reverse impression shall bear the design of -

- (i) a portrait of Sir Francis Drake with his ship the "Golden Hind", coconut palms and coconuts with the inscriptions "TRADERS OF THE WORLD" and "SIR FRANCIS DRAKE" and the value of the coin; or
- (ii) a Roman ship with a map of the trading area in the background and two lions with the inscription "TRADERS OF THE WORLD" and the value of the coin; or
- (iii) a 14 century Venetian trade ship with Oyster pearls in the background, a gondola passing beneath the Bridge of Sighs and Oysters in the foreground with the inscription "TRADERS OF THE WORLD" and the value of the coin; or
- (iv) a Portuguese ship from the 1500's leaving Lisbon harbour with gold bars in the foreground with the inscription "TRADERS OF THE WORLD" and the value of the coin; or
- (v) a Spanish Galleon from the 1600's with a map of America and Europe in the background and diamonds, emeralds and cocoa in the foreground with the inscription "TRADERS OF THE WORLD" and the value of the coin; or
- (vi) a Spanish Galleon under attack from an English pirate ship with a cameo of Queen Elizabeth I and jewellery encircled around her with the inscription "TRADERS OF THE WORLD" and the value of the coin; or
- (vii) Captain Bligh on the coast of the West Indies with bread fruit in the foreground and his ship HMS Bounty in the background with the inscription "TRADERS OF THE WORLD" and the value of the coin; or
- (viii) a portrait of Captain James Cook with his ship HMS Resolution in the background with a Beaver in the

- foreground with the inscriptions "TRADERS OF THE WORLD" and "CAPTAIN JAMES COOK" and the value of the coin; or
- (ix) a Phoenician galley leaving a Phoenician harbour with Murex shells with the inscription "TRADERS OF THE WORLD" and the value of the coin; or
- (x) a Viking ship travelling between Greenland, Iceland and Norway with Walrus tusks and fish with the inscription "TRADERS OF THE WORLD" and the value of the coin; or
- (xi) a portrait of Marco Polo with a Venetian round ship and spaghetti and black pepper in the foreground with the inscriptions "TRADERS OF THE WORLD" and "MARCO POLO" and the value of the coin; or
- (xii) a Hansa Kogge with the map of the Hanseatic leagues trading areas (northern Europe) with gold and silver coins above the ship with the inscription "TRADERS OF THE WORLD" and the value of the coin; or
- (xiii) British ships anchored in Boston Harbour with cargo of tea chests being thrown over by American colonists to onlookers with the inscription "TRADERS OF THE WORLD" and the value of the coin; or
- (xiv) Christopher Columbus with his ship the "Santa Maria" and cloves in the foreground with the inscriptions "TRADERS OF THE WORLD" and "CHRISTOPHER COLUMBUS" and the value of the coin; or
- (xv) Sir Walter Raleigh on new land with his ship discovering potatoes and the tobacco plant with the inscription "TRADERS OF THE WORLD" and the value of the coin; or
- (xvi) a Chinese trading junk from the 1400's with a map of Indian and Chinese seas in the background and Chinese porcelain and a silk moth resting upon a role

of silk in the foreground with the inscription "TRADERS OF THE WORLD" and the value of the

Legal Tender.

4. The said coins shall be current and legal tender in Gibraltar.
