## GIBRALTAR COINAGE ACT, 1990

### ISSUE OF THE QUEEN ELIZABETH II CORONATION COLLECTION COINS NOTICE 2022

In exercise of the powers conferred on him by section 2 of the Gibraltar Coinage Act, 1990, and of all other enabling powers, the Minister responsible for finance has issued the following Notice—

#### **Title and commencement.**

1. This Notice may be cited as the Issue of the Queen Elizabeth II Coronation Collection Coins Notice 2022 and comes into operation on the day of publication.

#### **Issue of new coins.**

2.(1) New coins of cupro nickel, silver, gold and platinum in the denominations of a 1/25, ½ crown, one crown, two/double crowns, ten pounds, twenty- five pounds, 100 Pounds and one Sovereign shall be made.

(2) In the making of the said coins, the millesimal fineness or composition of metals, diameters, shapes and other specifications shall be as set out in Parts II, VII and IX of the Schedule to the Gibraltar Coinage Act, 1990.

(3) In the making of the said coins, a remedy (that is a variation from the standard weight) shall be allowed as set out in the said Parts of the Schedule.

#### **Design of the coins.**

3. The design of the coins authorised by this Notice shall be as follows –

- (a) the sovereign coins shall bear on the obverse impression the effigy of Her Majesty Queen Elizabeth II with the inscription ‘ELIZABETH. II. DEI. GRA REGINA. GIBRALTAR’ bordering the top edge, date of the year below;
- (b) the crown and pound coins shall bear on the obverse impression the effigy of Her Majesty Queen Elizabeth II with the inscription ‘ELIZABETH II. D.G. REGINA. GIBRALTAR’ bordering the top edge, date of the year and value below;
- (c) the reverse design depicts an image of Queen Elizabeth II seated wearing the coronation crown, holding the coronation orb and sceptre. In the background are

the iconic windows and ceiling of Westminster Abbey. The inscription around the edge reads 'HER MAJESTY QUEEN ELIZABETH II – DIEU ET MON DROIT';

- (d) the reverse design depicts an image of the sovereign's sceptre. In the background are the iconic windows and ceiling of Westminster Abbey. The inscription reads 'I WILL PERFORM AND KEEP';
- (e) the reverse design depicts an image of the sovereign's orb. In the background are the iconic windows and ceiling of Westminster Abbey. The inscription reads 'THE THINGS WHICH I HAVE', 'HERE BEFORE PROMISED';
- (f) the reverse design depicts an image of the coronation crown. In the background are the iconic windows and ceiling of Westminster Abbey. The inscription reads 'SO HELP ME GOD'.

**Legal Tender.**

- 4. The said coins shall be current and legal tender in Gibraltar.
