Revoked Subsidiary 1990/152

1. These Regulations may be cited as the Land Titles (Register) Regulations, 1990 and shall come into effect on the 8th day of November, 1990.

Form of application.

2. An application to register a deed in the Land Titles Register (hereinafter referred to as "the Register") shall be in the form provided for in Schedule 1 to these Regulations.

Endorsement.

3. The endorsement of a deed by the Registrar of Land Titles (hereinafter referred to as "the Registrar") in accordance with section 3(4)(b) of the Gibraltar Land Titles Act shall be in the form provided for in Schedule 2 to these Regulations.

Application for registration.

4. Every application to the Registrar for registration of a deed in the Register shall be in the form provided for in Regulation 2 and shall be accompanied by the deed in respect of which the application for registration has been made together with the fee described in Regulation 6.

Form of Register.

5. The Registrar shall keep the Register in the form determined by him to be the most appropriate to enable a record of deeds to be maintained by reference to Crown Property Numbers.

Fees.

6. The fee in respect of an application for registration in the Register is $£52.00^{\circ}$ for each deed so registered and endorsed.
