GIBRALTAR MERCHANT SHIPPING (SAFETY, ETC) ORDINANCE 1993

GIBRALTAR MERCHANT SHIPPING (SAFETY RULES AND STANDARDS FOR PASSENGER SHIPS ON DOMESTIC VOYAGES) (AMENDMENT) REGULATIONS 2004

In exercise of the powers conferred on it by sections 59, 62, 63 and 118 of the Gibraltar Merchant Shipping (Safety, etc.) Ordinance, 1993 and all other enabling powers, the Government, for the purposes of transposing into the law of Gibraltar Commission Directive 2003/75/EC of 29 July 2003 amending Annex I to Council Directive 98/18/EC on safety rules and standards for passenger ships and for completing the transposition of Article 7 of Directive 2002/84/EC of the European Parliament and of the Council of 5 November 2002 amending the Directives on maritime safety and prevention of pollution from ships which amends Council Directive 98/18/EC on the safety rules and standards for passenger ships, has made the following Regulations:

Title.

1. These Regulations may be cited as the Gibraltar Merchant Shipping (Safety Rules and Standards for Passenger Ships on Domestic Voyages) (Amendment) Regulations 2004.

Amendment to regulation 2.

2. Regulation 2(1) of the Gibraltar Merchant Shipping (Safety Rules and Standards for Passenger Ships on Domestic Voyages) Regulations, 2003 is amended–

 (a) in the definition of "Directive" by inserting "and Commission Directive 2003/75/EC of 29 July 2003 amending Annex I to Council Directive 98/18/EC on safety rules and standards for passenger ships" after the words "prevention of pollution from ships";

- (b) in the definition of "GMDSS" by substituting " in its up-todate version as in force" for the words " which are applicable";
- (c) in the definition of "High Speed Craft Code" by substituting "in its up-to-date version as in force" for the words "which are applicable";
- (d) in the definition of "International Conventions" by substituting "in its up-to-date version as in force" for the words "that are applicable"; and
- (e) in the definition of "Intact Stability Code" by substituting "in its up-to-date version as in force" for the words "which are applicable".
