**GIBRALTAR MERCHANT SHIPPING (SAFETY, ETC.)  
ORDINANCE, 1993**

**GIBRALTAR MERCHANT SHIPPING (PORT WASTE RECEPTION  
FACILITIES) (AMENDMENT) REGULATIONS, 2003**

In exercise of the powers conferred on it by section 98 and 110 of the Gibraltar Merchant Shipping (Safety, etc.) Ordinance, 1993, and all other enabling powers, the Government has made the following Regulations:

**Title and commencement.**

1. These Regulations may be cited as the Gibraltar Merchant Shipping (Port Waste Reception Facilities) (Amendment) Regulations, 2003 and shall be deemed to have come into operation on 31 July 2003.

**Amendment to regulation 1.**

2. Regulation 1 of the Gibraltar Merchant Shipping (Port Waste Reception Facilities) Regulations, 2002 (the principal Regulations) is amended—

- (a) by substituting the definition of “Convention” for the following definition:

““Convention” means the International Convention for the Prevention of Pollution from ships 1973 as amended by Protocol of 1978 (Marpol 73/78), relating to that Convention in its up-to-date version;” and

- (b) in the definition of “Directive” by inserting “as amended” after the words “cargo residues”.

**Amendment to regulation 3.**

3. Regulation 3 of the principal Regulations is amended—

- (a) in subregulation (2), by substituting paragraph (c) of regulation 3(2) with the following paragraph–

- “(c) ships owned or operated by a State and used, for the time being, only on government non-commercial service.”; and

- (b) in subregulation (3), by substituting “14(4)” for “14(5)”.

**Amendment to regulation 8.**

4. Regulation 8 of the principal Regulations is amended by–

- (a) inserting “from the commencement of these Regulations” at the end of paragraph (a);
- (b) substituting a full-stop for the comma at the end of paragraph (c); and
- (c) deleting the words “whichever is the sooner” at the end of the regulation.

**Amendment to regulation 12.**

5. Regulation 12 of the principal Regulations is amended in subregulation (1) by deleting “or in a form substantially to the like effect”.

**Amendment to regulation 13.**

6. Regulation 13 of the principal Regulations is amended–

- (a) in subregulation (2) by substituting “port of delivery” for “next port of call”;
- (b) in subregulation (3), by substituting–
  - (i) “port of delivery” for “next port of call” in line 4; and
  - (ii) “intended port of delivery” for “next port of call” in lines 5 and 6.

**Amendment to regulation 14.**

7. Regulation 14 of the principal Regulations is amended in subregulation (2) by inserting “and he may also authorise the Captain of the Port to reduce or remit such fees”.

**Amendment to regulation 17.**

8. Regulation 17 of the principal Regulations is amended in subregulation (2) by substituting “a” for “another” in line 3.
