ADMINISTRATIVE INSTRUCTIONS UNDER THE MERCHANT SHIPPING (SAFETY, ETC.) ORDINANCE 1993

ADMINISTRATIVE (AMENDMENT) INSTRUCTIONS 2006

In exercise of the powers conferred by Section 3 (5) of the Gibraltar Merchant Shipping (Safety etc.) Ordinance, 1993 the Maritime Administrator has made the following Administrative Instructions—

Title.

1. These Administrative Instructions may be cited as the Administrative (Amendment) Instructions 2006.

Amendments to Legal Notice No. 68 of 2004.

- 2. The **Administrative Instructions** under the Gibraltar Merchant Shipping (Safety, etc.) Ordinance 1993 which were published as Legal Notice No. 68 of 2004 are amended—
 - (a) at pages 1 and 2, by deleting "Notwithstanding anything contained in the Schedule of the Gibraltar Merchant Shipping (Manning, Training, Certification and Related Seafarers' Matters) Regulations 2002 (Legal Notice No. 7 of 2002), the Administrative Instructions specified above shall have effect.";
 - (b) in the preamble to each of the Administrative Instructions No. STCW-1 to 14, by substituting "Gibraltar Merchant Shipping (Manning, Training and Certification for Seafarers) Regulations 2006" for "Gibraltar Merchant Shipping (Manning, Training, Certification and Related Seafarers' Matters) Regulations 2002";
 - (c) in Administrative Instruction No. STCW-1-

- (i) in paragraph 5, by inserting after the words "Restricted Operator's Certificate in GMDSS." the following sentence-
 - "In the case of Masters and Chief Officers a General Operator's Certificate is required."; and
- (ii) in TABLE 2, in the row for Unlimited Trading Area and Propulsion Power (KW) 750 or more, but less than 3,000, by substituting a hyphen "-" for the figure "1" in column 3 for Reg. III/2 Ch. Engineer, and in column 6 for Reg. II/3 Ch. Engineer, by substituting the figure "1" for the hyphen "-";
- (d) in Administrative Instruction No. STCW-4-
 - (i) in Form No 5, in the table for REQUIRED ATTACHMENTS WITH FORM-
 - (aa) in point 6 of MASTER/CHIEF MATE by inserting after the words "Evidence of GMDSS qualification" the hyphen and the words "—General Operator's Certificate (GOC)"; and
 - (bb) in point 5 of OFFICER NAVIGATIONAL WATCH by inserting after the words "Evidence of GMDSS qualification" the words "as a minimum, Restricted Operator's Certificate (ROC)"; and
 - (ii) in Form No 6, Annex I, under the heading "Gibraltar Regulations" by—
 - (aa) substituting "1. Gibraltar Merchant Shipping (Manning, Training and Certification for Seafarers) Regulations 2006" for "1. Gibraltar Merchant Shipping (Manning, Training, Certification and Related Seafarers' Matters) Regulations 2002"; and
 - (bb) substituting " 4. Gibraltar Merchant Shipping (Survey, Certification and Safety) Regulations

2004" for "4. Gibraltar Merchant Shipping (SOLAS) Regulations 2004"; and

- (e) in Administrative Instruction No. STCW-13, by substituting the following requirement for requirement at point 6–
- "6. produce as proof of nationality and date of birth, a copy of a passport provided a responsible person to the satisfaction of the Maritime Administrator, such as the master of the vessel, has certified it as a true copy."
