GIBRALTAR MERCHANT SHIPPING (SAFETY, ETC.) ACT 1993

GIBRALTAR MERCHANT SHIPPING (SURVEY, CERTIFICATION AND SAFETY) (AMENDMENT) REGULATIONS 2020

In exercise of the powers conferred upon it by sections 59,63(1) and 118 of the Gibraltar Merchant Shipping (Safety, etc) Act, 1993, and all other powers enabling, the Government, for the purposes of completing full implementation of the International Convention for Safety of Life at Sea (SOLAS) 1974 as amended by amendments adopted by the IMO by Resolutions in accordance with Article VIII of that Convention and the Codes referred to therein, and in particular, implementing the International Maritime Solid Bulk Cargoes Code (IMSBC Code), as amended, has made the following Regulations—

Title.

1. These Regulations may be cited as the Gibraltar Merchant Shipping (Survey, Certification and Safety) (Amendment) Regulations 2020.

Commencement.

2. These Regulations come into operation on the day of publication.

Amendment of Gibraltar Merchant Shipping (Survey, Certification and Safety) Regulations 2004.

3.(1) The Gibraltar Merchant Shipping (Survey, Certification and Safety) Regulations 2004 are amended in accordance with this regulation.

(2) For sub-regulation 51(3)(e), substitute—

“(e) the International Maritime Solid Bulk Cargoes Code (IMSBC Code), adopted by the IMO by Resolution MSC.268(85), as amended from time to time.”.

(3) For sub-regulation 55(6)(e), substitute—

“(e) Section 9 of the International Maritime Solid Bulk Cargoes Code (IMSBC Code), adopted by the IMO by Resolution MSC.268(85), as amended from time to time.”.
