**GIBRALTAR MERCHANT SHIPPING (FEES, CHARGES AND  
TAXES) (AMENDMENT) REGULATIONS 2012**

In exercise of the powers conferred on it by section 86(a) of the Gibraltar Merchant Shipping (Registration) Act, 1993, section 118(1) (e) of the Gibraltar Merchant Shipping (Safety, etc. Act 1993, and all other enabling powers, the Government has made the following Regulations—

**Title and commencement.**

1. These Regulations may be cited as the Gibraltar Merchant Shipping (Fees, Charges and Taxes) (Amendment) Regulations 2012 and come into operation on 1 May 2012.

**Amendment to the Gibraltar Merchant Shipping (Fees, Charges and Taxes) Regulations 2009.**

2. The Gibraltar Merchant Shipping (Fees, Charges and Taxes) Regulations 2009 are amended by replacing the Schedule to those Regulations with the following—

ANNUAL TONNAGE TAX

1. An Annual Tonnage Tax (ATT) shall be due and paid in respect of every ship registered under these regulations, other than a ship of less than 24 metres registered length or under 150 gross registered tons which is plying in the Port of Gibraltar and licensed by the port authority under the Port Act.
2. The ATT shall be payable in advance before the first day of January of the year in respect of which it is due.
3. Vessels registered between the 1<sup>st</sup> November and the 31<sup>st</sup> December pay the following year's ATT in addition to the calculated ATT on the month of registration.
4. The ATT, based on the vessel's Gross Tonnage (GT), shall be payable at the following rates—
  - a. Up to and including 50,000 GT:  
£800 plus £0.07 per GT.
  - b. From 50,001 GT up to and including 100,000 GT - £800 plus £0.07 per GT up to and including 50,000 GT plus £0.04 per GT in excess of 50,000.
  - c. 100,001 GT or more - £800 plus £0.07 per GT up to and including 50,000 plus £0.04 per GT from 50,001 to 100,000 plus £0.02 per GT in excess of 100,000 subject to a maximum Annual Tonnage Tax payable in the sum of £9,000.

#### Survey, Audits and Inspection

Except where specifically provided in any Gibraltar Merchant shipping legislation for any fees or charges to be paid for the services of any surveyor appointed under section 52 of the Gibraltar Merchant Shipping (Safety, etc.) Act 1993, the Maritime Administrator shall charge fees in accordance with Table C below for carrying out surveys, audits or other inspections by a surveyor in Gibraltar and a fee in accordance with Table D below surveys undertaken by a surveyor stationed outside Gibraltar
