## **GIBRALTAR MERCHANT SHIPPING (SAFETY, ETC) ACT, 1993**

### **GIBRALTAR MERCHANT SHIPPING (ORGANISATIONS FOR INSPECTION, SURVEY AND CERTIFICATION OF SHIPS) (AMENDMENT) REGULATIONS 2015**

In exercise of the powers conferred on it by section 118 of the Gibraltar Merchant Shipping (Safety, etc.) Act, 1993, and all other enabling powers; and for the purposes of transposing into the law of Gibraltar Commission Implementing Directive 2014/111/EU of 17 December 2014 amending Directive 2009/15/EC with regard to the adoption by the International Maritime Organization (IMO) of certain Codes and related amendments to certain conventions and protocols, the Government has made the following Regulations-

#### **Title and commencement.**

1. These Regulations may be cited as the Gibraltar Merchant Shipping (Organisations for Inspections, Survey and Certification of Ships) (Amendment) Regulations 2015 and come into operation on the 31<sup>st</sup> December 2015.

#### **Amendments to the Gibraltar Merchant Shipping (Organisations for Inspection, Survey and Certification of Ships) Regulations 2011.**

2. The Gibraltar Merchant Shipping (Organisations for Inspections, Survey and Certification of Ships) Regulations 2011 are amended by substituting the following definition for the definition of “international conventions” in regulation 2-

““international conventions” means-

(a) the International Convention for the Safety of Life at Sea of 1 November 1974 (SOLAS 74) with the exception of chapter XI-2 of the Annex thereto;

(b) the International Convention on Load Lines of 5 April 1966; and

(c) the International Convention for the Prevention of Pollution from Ships of 20.12.2014 L 366/86 Official Journal of the European Union EN 2 November 1973 (MARPOL),

together with the protocols and amendments thereto, and the related codes of mandatory status in all Member States, with the exception of paragraphs 16.1, 18.1 and 19 of part 2 of the IMO Instruments Implementation Code, and of sections 1.1, 1.3, 3.9.3.1, 3.9.3.2 and 3.9.3.3 of part 2 of the IMO Code for Recognized Organizations, in their up-to-date version;”.
